The Regular meeting of the Iron County Board of Commissioners was called to order by Chairman, Tim Aho, at 4:00 p.m. in the Board of Commissioners Room. The Pledge of Allegiance was recited, and roll call was taken, with the following members present: Brennan, Coates, Leonoff, Peretto, and Aho.

Chairman Aho requested the addition of New Business #9, possible purchase of a backhoe for use at Pentoga Park.

Moved by Brennan, supported by Leonoff, to approve the Agenda as amended. Voice vote: Ayes 5. Nays 0 Motion carried.

Administrator Clisch noted a correction to the minutes of December 8, 2015 on Page T-279, the amount of \$2,000 to be taken from Line Item 101-216-811.000 should be \$3,000.

Moved by Peretto, supported by Brennan, to approve the Regular meeting minutes of December 8, 2015, as corrected. Voice vote: Ayes 5. Nays 0. Motion carried.

Moved by Coates, supported by Brennan, to appoint Roger Zanon to serve on the Authority on Aging Board to December 31, 2018. Voice vote: Ayes 5. Nays 0. Motion carried.

A brief discussion was held regarding the purchase of a used backhoe for use at Pentoga Park. Commissioners Leonoff and Coates felt it would be a good item to have and could be used for a lot of

The meeting of the Finance Committee of the Iron County Baord of Commissioners was called to order on January 28, 2016 at 1:00 p.m. in the Board of Commissioners Room by Acting Finance Chairman, Jim Brennan. The Pledge of Allegiance was recited, and roll call was taken, with the following members present: Leonoff and Brennan. Absent: Peretto. Commissioner Coates filled in for Peretto.

The Commitree reviewed the bills. Brennan noted that the appropriation to the Animal Shelter had been reduced by \$3,300 per year.

Treasurer Camps submitted journal entries dated 1/28/16.

Moved by Coates supported by Leonoff, to approve payment of the bills in the amount of \$572,590.68. Roll call: Ayes 3. Nays 0. Motion carried.

Moved by Leonoff, supported by Coates, to approve the submission of journal entries dated 1/14/16 to the full Board.

Brennan explained that he had been in contact with a recruiting firm to discuss the possibility of obtaining their services in finding a replacement for County Administrator, Sue Clisch. He noted that they are a company from Marquette, and that he had met with a representative of the company. Brennan asked for support from the Committee. Leonoff felt that this is something we have to get moving on. Coates felt that he would like to meet with the firm first.

Moved by Leonoff, supported by Brennan, to hire the firm of Stang Decision Systems for the purpose of recruiting a County Administrator, for a sum not to exceed \$6,000. Roll call: Ayes 2. Nays 1 - Coates. Motion carried.
