Mark Bromley from the ICECA updated the board on businesses that have applied for the fast-track grants. He also said that six municipalities have given funding to the ICECA. He also reminded everyone of the meeting schedule for the ICECA (the second Wednesday of the month at 3:00 p.m. with the place of the meetings rotating between Crystal Falls City and Iron River City Halls).

## January 11, 2022, Regular Meeting continued

Dan Hinch from Parks and Rec reported that they had their regular monthly meeting on January 3<sup>rd</sup> and recommended to the board that they adopt the 2022 - 2026 Recreation Plan and wanted to thank everyone who worked on the rec plan.

Treasurer Camps updated the board on the foreclosure/demolition projects her office is working on.

Emergency Manager Jones spoke with regard to the American Rescue Plan money updates.

Veterans Service Officer Gerald Williams reported on activities conducted in the Iron County Veterans Service Office.

No other Department Reports were given.

#### **Old Business:**

The distribution of the senior center millage was the next item on the agenda. As stated at a previous meeting, there are currently four senior centers in Iron County: Amasa, Alpha, Iron River and Crystal Falls. According to the millage language, \$10,000 shall be distributed to each Senior Center in Iron County and the balance distributed to the centers based upon the number of persons age 60 or older as determined in the last decennial census in each township, village and city within the County of Iron. The 2020 census figures have been released, but the age breakdown will be released at a later date. At

previous meetings, the Alpha Senior Center has been discussed with regard to it being shut down but because the Alpha Senior Center has not dismantled yet, it will still receive the distribution.

After more discussion with regard to the senior center millage, it was moved by Stafford, supported by Conery, to distribute the senior center millage as per the ballot language.

Discussion with regard to courthouse security was had. The cost of a metal detector was presented (approximately \$3,500.00). Peretto reported what Dickinson County pays per hour for retired law enforcement personnel that work at the Dickinson County Courthouse (\$16.80 per hour plus pay half of the cost of their uniform, vest and gun and after 1 year reimburse them for the remaining half). Jones said you would need two people per shift because of breaks, etc. Peretto said she would like to advertise for the position to see if there's interest. Sheriff Valesano said he would like to be involved in the hiring process as it would fall under the Sheriff's umbrella. Tinti asked what about before/after hours? Stauber said he would like to take it to the next step to see if there's any interest by any retired law enforcement to man the metal detector. A motion was made by Ofsdahl, seconded by Conery, to move forward with the Sheriff helping to develop a job description, and to see if there's any interest by individuals wishing to man the metal detector.

The Iron County's website was up for discussion. Stauber said it can use some updates, especially with regard to Pentoga Park. It was moved by Conery, supported by Ofsdahl, to move forward with the process to update the website. Voice vote, motion carried.

The Drain Commissioner issue was next on the agenda. Ofsdahl said we should meet with the Road Commission sooner than later to get this sorted out. Bill Casagranda, who was the Drain Commissioner prior to the Board voting to have that position be a non-elected position and for the Road Commission to handle it, was at the meeting. Casagranda said he hasn't been involved for the past year with regard to the drain commissioner but gave the status at the time he was the drain commissioner. There was a lot of discussion on easements, court orders and who should pay for the repairs to the dams. Thursday, January 13, 2022, at 5:30 p.m., Chairperson Mark Stauber called the meeting to order. The meeting was held in the Board of Commissioners Room. The Pledge of Allegiance was recited. Roll call was taken with the following members present: Chairperson Mark Stauber, Commissioners Jacob Conery, Jeff Ofsdahl and Mike Stafford. Absent: Commissioner Patti Peretto.

Also present: Dan Hinch, Bill Casagranda, Rich Sloat and Dan Germic from the Parks and Recreation Committee; Civil Counsel Steve Tinti and Clerk/Register Julie Kezerle.

Moved by Conery, supported by Stafford, to approve the agenda. Voice vote, motion carried.

Stauber called for Public Comment three times, with no comments voiced.

The only item on the agenda was to discuss Pentoga Park operations. There was a lot of discussion regarding what should be done to the park, better enforcement, getting a better reservation system and discussion with regard to possibly getting a campground host to help when the Park Manager is not there.

Stafford said it's a lot for one person to do. Tinti said if we develop rules, we need to enforce those rules. A campground host could help.

Stauber said the next steps are to explore a website design/reservation system, look at getting a campground host and for the Parks and Recreation Committee to come up with rules. Conery said we need to coordinate these types of meetings with John Lortie and Chris West so that they will be able to attend, since they are in charge of the operations at Pentoga Park.

After more discussion, Stauber stated that this was a good discussion and that we need to get together with John Lortie and Chris West.

It was then moved by Conery, supported by Stafford to adjourn the meeting. All in favor. Meeting was adjourned at 6:26 p.m.

Wednesday, January 26, 2022, at 5:30 p.m., Chairperson Mark Stauber called the meeting to order. The meeting was held in the Board of Commissioners Room and was a joint meeting with the Iron County Road Commission. The Pledge of Allegiance was recited. Roll call was taken with the following members present: Chairperson Mark Stauber, Commissioners Jacob Conery, Patti Peretto and Mike Stafford. Absent: Commissioner Jeff Ofsdahl.

Also present: Administrative Assistant Mary Dalpra, Civil Counsel Steve Tinti and Clerk/Register Julie Kezerle.

Also present from the Iron County Road Commission: Ronald Frailing, Dan Germic, Ernie Schmidt and Doug Tomasoski.

Moved by Peretto, supported by Conery, to approve the agenda. Voice vote, motion carried.

#### **Public Comment:**

Stauber called for Public Comment.

Diane Kut spoke with regard to many issues that could affect tourism and lake values, such as invasive species, milfoil problems and beavers that need to be addressed.

Mark Bromley also spoke with regard to the dams.

Harold Kallies, who owns Crystal Waters Resort on Fortune Lake, questioned the possibility of residents having to pay for any repairs to the dams. He stated that everyone uses the lake.

Cindy and Joe Rahoi also stated their opposition to the possibility of residents paying for the dams and that it's public lands.

### New Business:

The only item on the agenda was to discuss the Drain Commissioner duties. Tinti explained how the Drain Commissioner position is funded and how it became the responsibility of the Road Commission. In February 2020, the Iron County Board moved unanimously to eliminate the Drain Commissioner as an elected position and turn it over to the Road Commission effective 2021. The four lakes that the county is responsible to maintain lake levels on are Fortune, Sunset, Stager and Indian.

Germic had questions regarding easements for these lakes? Tinti said because we have had no limitations in the past, we have a historic footprint and acquired easements over time. However, if there is extensive work that needs to be done on Sunset Lake, Tinti could draft an easement if they so choose to have him do that.

Germic asked why the Drain Commissioner position was eliminated as an elected position and Schmidt asked the County Board if they would be interested in taking the Drain Commissioner back as an elected position. Stauber and Peretto said the Road Commission was a better fit because they have the equipment.

Frailing also had questions regarding the salary and expenses for the drain commission duties and cited various laws.

Schmidt again asked if the Drain Commissioner position would go back on the ballot? Tinti said it can't until November 2024, if the county board decided to reinstate the Drain Commissioner as an elected position.

# January 26, 2022, Special Board Meeting continued

Bill Casagranda was also in attendance at the meeting. Casagranda was appointed Drain Commissioner in March 2020, to fill Thomas Clark's (who passed away) term, which ended in December 2020. Casagranda reported to the board the condition of the dams when he took over. He also said he's had conversations with Tomasoski regarding being "contracted" by the Road Commission to fulfill the duties that the Drain Commissioner would do.

Tomasoski said Casagranda would have to be bonded, and there were questions on if Casagranda would use a county vehicle, and if Casagranda (in his capacity of his other job) could bid on jobs for the Road Commission if he was an "employee" or "contracted employee" of the Road Commission.

Tinti said that the Road Commission is stuck with it for the next three years and the responsibilities and powers are vested with the Road Commission. The County only "funds" the position.

Peretto said we have to do something and need to get Sunset Lake dam functioning and the County and Road Commission need to work together.

After more discussion, it was moved by Stafford, supported by Conery, to adjourn the meeting. All in favor. Meeting was adjourned at 6:45 p.m.
