

Resolution Establishing Compensation for Elected and Appointed Employees

Whereas; It is the responsibility of the Iron County, Michigan County Board of Commissioners to establish or approve appropriate compensation for elected and appointed employees of the County; and

Whereas; the Board of Commissioners has determined, after a diligent examination of the conditions which lead to the establishing of compensation, that it wishes to take the action described herein.

Now therefore be it resolved that, effective beginning with the first payroll period following January 1, 2019 compensation for the Fair Labor Standards Act exempt or elected individuals shall be set as described in Table 1 below,




