

To the Iron County Board of Commissioners:

The Apportionment Report was prepared by the Equalization Department. M.C.L. 211.37 requires the Iron County Board of Commissioners at its annual session in October to examine certificates and determine the amount of money to be raised for county purposes and direct the spread of taxes in terms of millage rates to be spread against the taxable valuations.

The certificates, statements and records submitted by the various townships, cities and village were examined and the attached rates represent a compilation of these documents. The certified rates as adjusted by Headlee M.C.L. Sections 211.34D and 211.34E are set for all the townships, cities and village in the county.

This report is a summary of millage rates by the various taxing authorities. There are also summaries showing the total tax rates by each taxing jurisdiction and each taxing authority.

The attached resolution if passed by the Board of Commissioners will authorize the Equalization Director to sign the certificates on which the attached tabulation was based. The action thereby authorizes and directs the various assessing officers to spread the rate against the 2023 taxable valuation.

RESOLUTION TO ADOPT THE 2023 APPORTIONMENT PLAN IRON COUNTY BOARD OF COMMISSIONERS


Whereas, the several Township Clerks and City Clerks in Iron County have caused to be filed in the Office of the Iron County Clerk, State of Michigan their certificates authorizing their levying certain millage to be raised in said townships and cities for township, city, school and other purposes for the year 2023.

Whereas, the tax certificates showing the certified rates, as adjusted by MCL 211.34, 211.34D, 211.24E and 211.34E of the Property Tax Laws, are authorized to be spread against State Taxable Valuations.

Whereas, the certified rates are subject to MCL 211.36 which allows additional millage approved by the electors on November 7, 2023 of a taxing unit to be certified for that calendar year, said millage would require Board approval.

Now, Therefore Be It Resolved, by the Iron County Board of Commissioners in a meeting assembled in the Commissioners Room in the Iron County Courthouse on October 10, 2023, that said millage respectively be and the same are hereby apportioned among the several townships and cities in Iron County in proportion to the valuation of taxable property herein, as determined by this Board of Commissioners in the year 2023 and respective apportioned millage together with the certified and authorized amended millage be levied for township, city and county purposes respectively be spread upon the assessment rolls for the several townships and cities for the year 2023, as follows, to wit:
