The Pledge of Allegiance was recited by all.

The agenda was approved on a motion by Archocosky, seconded by Conery. All approved.

The minutes of the May 17, 2023 regular meeting were presented to members. Conery made a motion to approve the minutes, seconded by Frailing and all approved.

Old Business: Hinch reported that he had led a tour of the Cooks Run Cabin for the Iron County Genealogical Society in October. Sloat reported that the roof project had started at the Cooks Run Cabin per his visit the day before the meeting.
