SECTION II
Deliverables

The "Public Use of Cooks Run" deliverables are requested to include the following:

1. A non-profit or governmental unit to operate a non-discriminatory public use program(s) of activities on a year round basis;
2. Conceptual and organization detail plan to provide non-discriminatory public use programs(s) on a year round basis;
3. A detailed method of financing, without support from the County of Iron, for the non-discriminatory public use program(s) on a year round basis;
4. A detailed tentative budget for first year of operations on a non-discriminatory public use program(s) on a year round basis;
5. A statement and methodology for assessing usage fees to be charged, if any, for the non-discriminatory public use of program(s) on a year round basis;
6. A detailed method of financing, without the support from the County of Iron, for the maintenance and improvement of **Cooks Run**;
7. A detailed method of staffing the program(s) and the hours of operation of the program(s);
8. A central telephone number and/or internet address for information on and/or enrollment in any programs to be offered;
9. A listing of any local, regional or national organizations that will be involved with or providing technical and/or operational support of the program(s) with specific details of all operational support to be provided.

SECTION III
Proposal Outline

Your organization is invited to submit a written proposal describing the benefits that the County of Iron will derive by selecting your

organization for the providing of "Public Use of Cooks Run". Please submit the proposal as follows:

1. Transmittal Document;
2. Executive Summary;
3. Your proposal for meeting County needs and stated deliverables; and
4. A statement signed by an authorized official of your organization.

SECTION IV
Organization Background

1. Provide general information about your organization related to size, history, number of staff and growth over the last five (5) years;
2. Describe the compliance of your organization to provide the stated deliverables and plans to meet or exceed the standards set forth herein;
3. Provide a summary of any pending lawsuits against your organization and what judgments have been entered against your organization or its employees in the past five (5) years;
4. Identify the leadership team that would be assigned to "Public Use of Cooks Run" and their relevant professional experience;
5. Provide a detailed description of how your organization intends to financially capitalize the operation necessary to provide the service required in this request for proposal;
6. Provide a "Public Use of Cooks Run" Service Contract which would be proposed by your organization if the County should desire to proceed;

SECTION V
Proposal Format And Timetable

Please submit seven (7) copies of your proposal and any additional documents you wish to provide. Your proposal and additional documents should be delivered to the project representative in a sealed envelope

clearly marked on the outside, "Public Use of Cooks Run Service Proposal" on, or before June 3, 2026 at 2:00 p.m.

Each proposal shall be considered binding and in effect for a period of ninety (90) days and shall affirmatively state all program(s) shall operate in compliance with the deed restriction for **Cooks Run**.

The County reserves the right to reject proposals or parts thereof, the right to waive any irregularities, inconsistencies and bidding provisions or take whatever action that is in the County's best interest as determined by the Board of County Commissioners of the County of Iron.
